Extracts from the Articles of Association of Herbert Collins Estates Limited **Benefit to the Community**

C. It is an object of the company to exercise the rights and powers granted by ownership of the land aforementioned in a manner that preserves or enhances the amenity of the area.

Powers

D. (2) The company may do all such lawful things as may further the company's objects and, in particular, but, without limitation, may borrow or raise and secure the payment of money for any purpose.

Appointment of Directors

17. (1A) One director who is an individual member of the company and willing to act as a director, and is permitted by law to do so, may be appointed at each annual general meeting of the Herbert Collins Estates Residents' Association.

(1B) The period of office of a director shall be three years; a retiring director shall be eligible for reappointment.

Directors' general authority

3. Subject to the articles, the directors are responsible for the management of the company's business, for which purpose they may exercise all the powers of the company.

Members' reserve power

4. (1) The members may, by special resolution, direct the directors to take, or refrain from taking, specified action.

(2) No such special resolution invalidates anything which the directors have done before the passing of the resolution.
